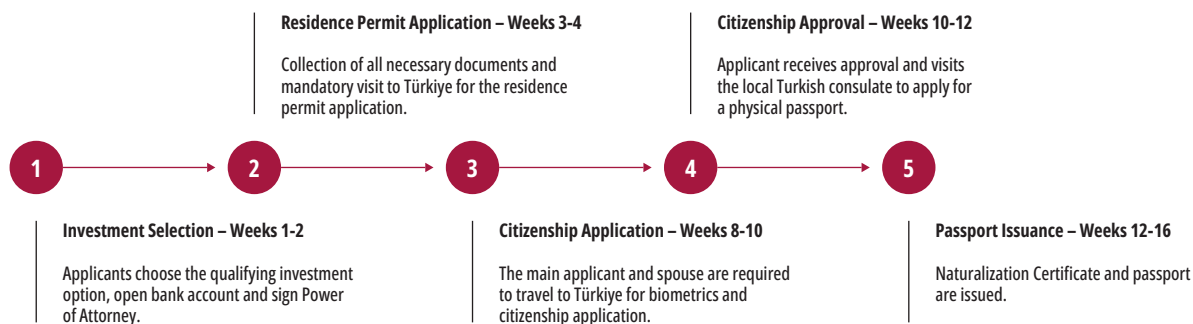
Commit at least US\$500,000 into real estate investment fund share or venture capital investment fund share.
